This certification offers buyers confidence that the EHR systems they choose will meet established standards for functionality, interoperability, and security.

InteliChart, as a certified Health IT developer, does not currently offer Predictive Support Interventions (DSI) as part of any of our Health IT modules, as defined by the Office of the National Coordinator (ONC) and the Assistant Secretary for Technology Policy (ASTP).

InteliChart will adhere to all applicable and mandatory standards for the Decision Support Intervention (DSI) criterion under (§)170.315(b)(11) by implementing the United States Core Data for Interoperability (USCDI), July 2020 Errata, Version 1 (v1) (incorporated by reference, see § 170.299). Our DSI will intended to enhance clinical decision support within EHR systems by supporting clinical workflows with interventions that consider the entire patient encounter, rather than isolated clinical elements to enable and empower the patients.

The adoption of these mandatory standards will be reviewed and updated on a quarterly basis and will be managed by this organization.

The compliance for this certification criterion was evaluated through an attestation. Functionality Testing and Risk Management Summary Information are not included in the current scope of this criterion. Our organization is not certified for (§)170.315(a)(9) Clinical Decision Support (CDS), and there are no references to this criterion on our publicly accessible website or in our marketing materials. In accordance with the standards set by the ONC, other federal agencies, and programs under the HTI-1 final rule, as well as to support the Certification Program and enable modular, extensible future updates, we have discontinued the use of year-specific editions in the naming convention of certification criteria.
